Executive summary				

Introduction:

The Trust's focus on inequality in health outcomes is now coming to life in a number of areas and an Inequalities Work Plan has been developed to give this structure. This has been broken down into two key areas of focus: Risk Factor Management including obesity and smoking and the nationally recognised CORE20Plus 5 approach (most deprived 20% of the population, core ICS groups with poorer health outcomes, plus 5 clinical areas of health inequalities) with a focus on ensuring access to care and treatment is equitable for all our patients and communities.

Health behaviours and risk factors

- Tobacco Treatment: Funding has now been secured for two years and initial roll out will commence in our respiratory wards and EAUs in July.
- Healthy Eating Adults: A refresh and refocus for this initiative is underway with the Deputy Chief Nurses now leading this work.
- Healthy Eating QI Project, Children & Young People: The "Nourish" pilot in CO15 has now concluded and evaluation has shown that an improvement has been seen in a number of areas to include; activity levels, waist circumference and importantly self-esteem. Options to expand the programme and funding are being explored.
- Making Every Contact Count: Further roll out has taken place in 50 clinics and feedback so far extremely positive. Funding has now ended for the MECC project lead. Further funding streams are being explored.
- Free MECC training continues to be delivered across the Trust.

Identification and prioritisation of population groups with poorer outcomes

- People referred in on Cancer pathways
 - BI analysis on referral rates, diagnoses and survival rates. Work programme being developed across Cancer Board, Inequalities group and partner organisations to explore and understand the barriers to access for care with Lung and Breast cancer the initial areas of focus.
- Do Not Attend Rates
 - Working with GPs in Tendring to better understand barriers to not attending hospital for patients in our more deprived areas. Work programme to be extended for Ipswich and East Suffolk
- Ongoing development of the Clacton Diagnostic hub

Programme: An ESNEFT Inequalities Strategy has been developed and key stakeholders/partners are feeding into this collaborative document.

Next Steps:

- Finalising of ESNEFT Strategy
- Secure funding to expand Nourish pilot in Colchester and also IES.
- Commence Tobacco Treatment pilot and gather initial data
- Analysis of Lung Cancer diagnosis in our most deprived areas

 Review of patients with Learning disabilities awaiting surgery – incorporating learning from elective prioritisation programme with view to extending to outpatient and diagnostic services
