The calendar of Board and Committee meetings is presented for the Board's consideration. It is proposed that the Board will continue with a broadly similar pattern of meetings, generally on the first Thursday of each month with a public session in every second month. There are three exceptions: the meetings in January and April 2023 would be slightly out of sequence, and February 2023 would see only a seminar session rather than a formal Board meeting. It is proposed that the Committee pattern is changed by ending the practice of holding a number of Board Committees in the same week of each month, which has placed significant pressures on some colleagues who have commitments to all of those meetings. Dates of meetings in 2023

The pattern of meetings for the Board and Board Committees is set by the Board; for itself, in its annual decision on meeting dates, and for Board Committees in their terms of reference.

This paper-

Invites the Board to agree the dates for its meetings in 2023; Note the proposed dates for the various Board Committees in 2023.

It is proposed to keep the pattern for the Board meetings, where the Board will meet monthly with a public session being held every two months. The public sessions will continue to be rotated between the Ipswich and Colchester areas, with the Board continuing to meet in person (subject to any national requirements that have an impact on this).

The pattern of continuing the Board meetings on the first Thursday of the month is also proposed. There are two exceptions to this; the January meeting, as in previous years, is proposed for the second Thursday of the month owing to the impact of the Christmas period. Additionally, to avoid disruption from the Easter period, the meeting that would usually be held on 6th April 2023 (directly before the Easter Bank Holiday weekend) is being proposed for 30th March 2023 (a week earlier).

Additionally, given the limited period between the dates for the January and February 2023 meetings, it is proposed that there would not be a formal private session of the Board in February 2023; an informal seminar session would be held, which should release time for colleagues. A provisional date for the approval of the Annual Report and Accounts has been provided, but that is subject to the publication of national timelines which are expected in 2023.
