Workforce Safeguards Report	In October 2018 NHS Improvement (now NHSE) launched a Workforce Safeguards toolkit to direct Trusts to ensure that there were appropriate safeguards in place that supported NHS boards to make informed, safe and sustainable workforce decisions. In line with the toolkit, the Chief Medical Officer/Deputy Chief Executive, Chief Nurse and Director of People and Organisational Development were satisfied with the outcome of the assessment that staffing was safe, effective and sustainable for 2023/24.	The Board reviewed and approved the Executive Team's assessment of assurance against the workforce safeguard indicators and the continued delegation of ongoing monitoring of workforce safeguards to the quarterly People and Organisational Development Committee.

Patient Experience	The Board received a patient experience, remotely, introduced by the Acting Chief Nurse relating to a patient's care journey following a diagnosis of breast cancer.	The Board noted that whilst it had been positive to hear of the compassionate care provided in this case, it was important to ensure this was the experience for all patients.	
Chair's update	 The Chair provided an update on key matters arising since the last meeting: Consultant orthopaedic surgeon Mahbub Alam had been presented with The Murray Matthewson East of England Trainer of the Year Award. The Chair had recently attended the opening of the Butterfly Centre which provided a calming environment to offer support to the families and carers of patients who were in the last 12 months of life. She would be spending a day with community services including an award-winning initiative, Access to Stack programme, where community teams worked with the ambulance service to provide care closer to home that had accepted more than 1100 patients since the programme began in November. Innovations in patient care including a groundbreaking pilot to improve early diagnosis for people at risk of lung cancer in Clacton. Gynaecology patients at Colchester Hospital could now get faster care to rule out cancer thanks to the development of two new treatment rooms and three newly appointed nurses. Patients with heart failure could now have lifesaving surgery at Ipswich Hospital, instead of having to travel to specialist centres in the region. 		
Chief Executive's Update	 The Chief Executive and Chief Medical Officer/Deputy Chief Executive provided an update on key operational matters. The Chief Executive thanked the Board for its support of him taking on the interim Chief Executive role at the Norfolk and Norwich University Hospitals NHS Foundation Trust observing that this was an opportunity for both organisations to take learning from each other. Following the NHS England meeting yesterday he felt that leadership would come under significant scrutiny in a number of areas and that he hoped the responses were as measured as they should be. The massive disruption to the Trust from the industrial action was noted and the Chief Executive advised that he continued to try to influence the 	The Board received and noted the verbal update provided.

	 need for discussion and compromise to address the adverse impact on patients. Thanks were expressed to leaders of the organisation dealing with the industrial action and the often unsung heroes in administration teams who were having the conversations with patients on a daily basis regarding cancellation of appointments. The Chief Medical Officer/Deputy Chief Executive agreed that it was a huge team effort to manage the industrial action and the focus was on keeping patients safe. Whilst no overt patient safety issues had occurred the adverse impact on patients from delays in treatment was recognised. During July there had been 400 less admissions and over 3500 outpatient appointments cancelled, and it was felt that there would be a similar impact in August. Plans were being made for the upcoming industrial action by consultant and junior doctors Positively, teams in cancer and diagnostics were maintaining standards which would be discussed later on the agenda. Uptake of COVID-19 vaccination was encouraged. 		
Quality and Patient Safety	 The Board received the Key Issues report from the Committee held on 22 August 2023 and the relevant part of the Integrated Performance Report. The focus remained on patient safety during industrial action. The Committee had considered the outcome of the LL trial and the Trust's response. A thorough review had been carried out of Learning from deaths and the associated plans.
