The Suffolk & North East Essex Integrated Care Board (ICB) has not held a further meeting since the last meeting of the ESNEFT Board on 5<sup>th</sup> October which received a report of the proceedings of the SNEE ICB Board meeting held on 26<sup>th</sup> September 2023.

## Board Briefing: Suffolk & North East Essex Integrated Care Partnership (ICP) 13th October 2023

The **Suffolk & North East Essex (SNEE) Integrated Care Partnership (ICP) Board** held a meeting on 13<sup>th</sup> October 2023. The key matters discussed at the October 2023 SNEE ICP meeting were as follows:

- Susannah Howard, the ICP Director, provided a report from the ICS System Learning from Winter Pressures 22/23 away day event held on 8<sup>th</sup> September 2023, The ICP approved the report, agreed to share it with relevant organisational Boards and/or system groups to inform planning for future system pressures, and discussed the potential to plan a similar workshop in Spring 2024 to reflect on winter 23/24;
- Detective Superintendent Angus Moir from Suffolk Police and Chief Superintendent Leighton Hammett from Essex Police jointly presented a Right Care Right Person in Suffolk and Essex report, this comprised of two presentations providing an overview of the approach to the delivery of this initiative in Essex and Suffolk;
- The ICP Board noted and endorsed a summary of the East of England Ambulance Service NHS Trust (EEAST)
  Clinical Strategy as published on 27<sup>th</sup> September 2023, which partners had fed into as part of the development
  process;
- Dr Shane Gordon, the Trust's Director of Strategy, Research and Innovation, and Ms Nicola Cottington, Chief Operating Officer at West Suffolk NHS Foundation Trust jointly presented an update on the two Trusts' shared vision and principles for collaboration and the ongoing work to establish collaborative governance of this programme of work. The ICP Board noted the progress of provider collaboration and discussed the opportunities arising from this.
